# Tim Fair, President & CEO - Clinton County Catalyst - Deb Parker, Karen Schafer, Grant Writers:

Mr. Fair explained Clinton County Catalyst (C3) is a nonprofit, public-private organization dedicated to enhancing the economic vitality of Clinton County. They are fully funded by their membership, which includes businesses, educational institutions and municipalities. They are governed by their Executive Board, which is comprised of investors throughout Clinton County and Mid-Michigan. The benefits program offers different levels of investment. # **Vector - IT Information (Tyler Samp):**

We are paying VC3 \$3,495 annually, and it goes up every year.
