CLERK/BILLS - FOR APPROVAL:

Clerk Claudia supplied the Board with the Check Disbursement Report for this month's meeting. Check numbers 11454 and 11455 to Consumer's Energy were voided. BS&A was updating software, and the checks printed with X's on them, no amount. We ran out of Payroll checks, so check number 11461 was part of the payroll checks. After speaking with our Auditors, we will be using General Fund checks going forward for payroll, and close the current payroll account. The money is being transferred from General Fund anyway to the Payroll Account.

NEW BUSINESS:

Phil Hanses, Clinton County Drain Commissioner:

Phil reported on the maintenance work on the Dean Drain in Ovid Township. It's in Sections 28, 32 and 33 of the Township, and has a total length of 2.29 miles. It is an open ditch from the South Maple Drain upstream to Taft Road. From there upstream is a tile drain. The length of the open ditch is 1.04 miles, and the tile drain is 1.25 miles. The drainage district encompasses an area of about 415 acres. Phil provided the Board members with maps for reference.

The outlet of the tile drain on the north side of Taft Road is submerged due to sediment accumulation in the open ditch. They propose cleaning out approximately 2,830 feet of the open ditch that was last cleaned out in 1984. It will be necessary to clear trees along one side of the drain in order to do the work. The estimated cost could be \$20,000.

- County Commissioner's Report Val Vail-Shirey
 - The County Planning Commission is working on updating 18 Ordinances.
 - The Board of Commissioners passed the Wind and Solar Ordinances, and they are in effect now.
 - The Stand-Alone Battery Storage Ordinance was passed by the Planning Commission, and will be before the Board of Commissioners next Tuesday.
 - o There are two openings in the Community Development Office.
 - The Petition deadline for the local control/zoning for wind and solar is next Tuesday, May 28.
 - o A study was done on County employees' salaries. That will be presented to the Board of Commissioners next Tuesday also.
 - o Val reported she has filed for Re-Election as the District 1 Commissioner.

Mr. Keith Jones questioned Commissioner Val regarding Ovid Township Ordinances not carrying over to the new website, such as noise, blight, liquor control, land divisions. Does Ovid Township fall under the County Ordinances? Val explained there are some ordinances that townships can do. Noise is one that townships could do, but they can't enforce it. Those are really tough. You have to look at the laws. Townships are going to fall under the County Ordinances, unless you become a Charter Township.

- Assessor Report Peggy Lidgard
 - o Finished taking pictures of the Township.
 - 800 pictures or attachments have been added since the last Board meeting, i.e., building permits, property transfer affidavits, principal residence exemptions, and now downloaded to Treasurer Nancy's computer.
 - Around 50 data surveys have been received back; about 26 percent have responded.
 - Since the first of the year there has been 37 sales. Out of those, only five
 (5) of them have been arm's length sales.
 - Received 15 permits from the County so far this year, and those have been entered in.
 - Peggy reported she took an L-4029 Class last week, along with Nancy and Claudia. Ovid Township's L-4029 form cannot be completed yet because two of the items on the form will be voted on in the August Election.
